- Taking longer than initially expected due to data issues, regulatory discoveries etc.
- Summary of changes:
 - o Natural resource buffers: simplified and unified; transition from zone to overlay

- Hillside code and overlay: some steeply sloped areas were removed from the natural resource overlay after methodology changed and older data sources were not very accurate so updating to integrate new DOGAMI landslide hazard data
- Not intending to change level of protection
- Next steps
 - O Will come back to CSWC with updated natural resource and hillside maps and codes
 - o Public review May-June 2020; hope to have these adopted and in effect by January 2021

 - O Bob motioned to approve all; Adam seconded; all approved
- Mid-year review annual work plan updates
 - O Mid-year update report shows status of all programs
 - O Most changes are in Stewardship and Events
- Mid-year review financial reports; year to date (YTD) through end of October
 - YTD revenue and expenses are lower than expected (33% through the year) but YTD expenses are exceeding YTD revenue. However, we had money in the bank at the start of the year
 - Expenses need to look into higher than expected Contracts/Professional Services spending; equipment rental is over budget due to summer events
 - Behind on individual donation and corporate giving although current report does not include end of year donations we still need to prioritize Gala and other events and donations
 - Now able to code all costs by admin or program(s)
- Committee Reports
 - O JEDI: Rachel is looking to organize the next JEDI Committee meeting in late Feb
 - Stewardship
 - Matt's backfill position: job posted and open until 2/25; Max (seasonal position)
 is stepping up and doing a great job
 - Digging into review of all compensation to ensure we're competitive, can retain staff and have clear career progression
 - Think we need more mid-level positions that reflect required leadership
 - Stewardship Saturday events are seeing high turnouts
 - o Fundraising:
 - February Board meeting will discuss fundraising targets and priorities for Board members
 - O Building:
 - Verified there is no asbestos
 - Have not heard price difference to coat vs. tear off and replace
 - Still waiting on contractor's proof of insurance and on response from Malarkey
 re: donations which would lower the cost but not critical to move forward
 - Move forward as soon as possible

- Standing JEDI topic:
 - O Kathy reviewed example of Ground Rules and shared a video (https://www.youtube.com/watch?v=hDd3bzA7450)
 - O Consider 5 mins at every meeting on terminology; quarterly deeper dive discussions on how to apply equity lens to decision making
